अटी व शर्ती

- १ अटी व शर्ती काळजीपुर्वक वाचुन दर नमुद करावे, एकदा भरलेले दर मागे घेता येणार नाही. दरपत्रकानुसार मंजुर करण्यात आलेल्या दरांव्यतिरिक्त अन्य कोणतेही दर देय होणार नाहीत.
- २ पुरवठा आदेश देऊनही साहित्याचा पुरवठा न केल्यास जेवढया रकमेच्या साहित्याचा पुरवठा केलेला नसेल तेवढया रकमेच्या ३% रक्कम दंडस्वरूपात म्हणुन सुरक्षा अनामत रकमेमधून जप्त करण्यात येईल.
- ३ दरपत्रकात मागीतलेलीच कागदपत्रे जोडावीत. अतिरिक्त कागद जोडण्यात येवू नये. जोडल्यास दरपत्रक रद्द करण्याचा अधिकार अधिष्ठाता, शासकीय आयुर्वेद महाविद्यालय, जळगाव यांना राहिल.

- ६ शासन निर्णय उद्योग व उर्जा विभाग दि. ०१.१२.२०१६ मध्ये नमुद केल्यानुसार पुरवठादाराच्या बाबतीत खरेदीच्या कोणत्याही टप्यावर अनियमितता/ गैरप्रकार/ नैतिक अधःपतन इतरही बाबी निर्दर्शनास आल्यास त्याबाबत शासन निर्णयामध्ये नमुद केल्यानुसार कार्यवाही करण्यात येईल.
- ७ यशस्वी दरपत्रक धारकाला पुरवठा आदेश निर्गमित केल्यानंतर १५ दिवसांच्या आत सदर वस्तुंचा पुरवठा करणे आवश्यक राहील. सदर वस्तुंचा पुरवठा केल्यानंतर ती तुटफुट अवस्थेत/ खराब झालेली असल्याचे निर्दर्शनास आल्यास सदर वस्तु स्वखर्चाने परत नेऊन त्याएवजी नवीन वस्तुंचा पुरवठा ०७ दिवसांचे आत करावा लागेल.
- ८ अधिष्ठाता, शासकीय आयुर्वेद महाविद्यालय, जळगांव हे सदर दरपत्रक स्विकारणे, रद्द करणे, यशस्वी दरपत्रक स्विकारण्याच्या पुर्वी किंवा यशस्वी दरपत्रक स्विकारण्यात आल्यानंतर देखील कोणत्याही वेळी रद्द करण्याचे अधिकार तसेच खरेदी प्रक्रियेच्या अटी व शर्तीमध्ये कोणताही बदल करण्याचा अधिकार राखुन ठेवत आहे.

इतर अटी व शर्ती

१	The successful supplier can appoint his territorial distributors at his own & at own risk at the time of supply after awarding of the quotation. However distributor should fulfil the criteria. Manufacturer will be solely responsible for all types of quality issues though supplies are made by distributor. Tenderer shall produce Certificate from Chartered Accountant for Annual turnover. Annual Turnover Should be 15 Lac or more for last 3 years
२	If the product is found to be not of standard quality the successful bidder will be liable to replace the entire quantity or make full payment of entire consignment against the particular invoice
३	Rates should be quoted including GST & all other Charges
४	The EMD, eligible for groups which bidder want to participate, shall be submitted through Demand Draft (DD) in favour of Dean, Government Ayurved College, Jalgaon. Demand Draft Should be of Nationalized bank
५	The supplier submitted without EMD will be summarily rejected.

6	Unsuccessful supplier EMD will be discharged/returned within a period of 60 days after award of contract to the successful supplier.
7	The supplier shall not be entitled for any interest on EMD
8	Rates should be quoted in Indian Rupees only for each of the required Equipment's separately, on Door Delivery basis according to the unit asked for strictly as per the quotation for the supply of Equipment's , etc. with conditions like 'AT CURRENT MARKET RATES' shall not be accepted. The Purchaser shall not be responsible for damages, handling, clearing, transport charges and will not be paid. The deliveries should be made as stipulated in the purchase order placed with successful bidder. Conditional tenders are not accepted and liable for rejection.
9	The price quoted by the supplier shall not in any case, exceed the Maximum Retail Price (MRP). The Purchaser at their discretion Will exercise the right to revise the price at any stage so as to confirm to the controlled price or MRP as the case may be. The discretion will be exercised without prejudice to any action that may be taken against the bidder Payment of all applicable taxes to concerned authority is the responsibility of the bidder.
10	In case of any enhancement in GST due to statutory Act of the Govt. Or any other taxes newly levied by Govt. after the date of submission and during the tender period, the quantum of additional GST so levied will be allowed to be charged extra as separate item without any change in price structure of the instruments and equipment's approved under the tender. For claiming the additional cost on account of the increase in GST, the bidder should produce a letter from the concerned Competent Authorities for having paid additional GST on the good supplied to the Purchaser and can also claim the same in the invoice.
11	Each item/materials will be evaluated separately
12	The successful supplier shall furnish the security deposit to the Purchaser within 15 days from the date of communication of Acceptance of Tender for an amount of 3% of the contract value, OR as per Clause 4.6 of Govt. Resolution by Industries, Energy & Labour Department, Maharashtra State, dated 1.12.2016 and enter into Contract Agreement on Rs. 100/- non-judicial notarised stamp paper. The cost of Stamp paper should be borne by the supplier.
13	In case the bidder quotes prices higher than MRP or/and fails to supply the goods consistently the bidders will be declared as a Fraudulent and defaulters
14	The Security Deposit should be in the form of Demand Draft in favour of Dean, Government Ayurved College, Jalgaon payable at Jalgaon. Bank Guarantee from any Nationalized bank.
15	<p>a) 3% security deposit may be forfeited for non-supplied items.</p> <p>b) If successful bidder fails to supply the goods same will be purchase from another bidder or from open market the cost difference amount will also be recovered from security deposit.</p>
16	If the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% of the delivered price the delayed goods for each week or part thereof of delay until actual delivery, up to a maximum deduction of 10%. In case of an order not exceeding Rs-2 Lac where as in case of an order 2 Lac & above penalty amount at the rate of 0.5% per week subject to maximum limit of 5%.

Rejected items must be removed by the bidders within 15 days of the date of rejection at their own cost and replaced immediately.</p>

The purchaser will be entitled to reject said goods/ stores/articles or such portion thereof as may be discovered not to conform to the said description and quality. Such rejection of the articles will be at the contractors risk and all the provisions herein contained relating to rejection of goods etc. Or such portion thereof if rejected by the purchaser otherwise the contractor shall pay to the purchaser such damages as may arise by reason of the breach of conditions herein contained.

Nothing herein contained shall prejudice any other right of the purchaser in that behalf under this contract or otherwise.
